- -、 依照教育部「大專校院因應嚴重特殊傳染性肺炎學生宿舍防疫管理指引(111 年 11 月 7 日修訂)」、教育部 1110822 大專院校防疫新制制訂及依照 111 年 11 月 7 日大專院 校防疫機制調整更新本規定。目的為因應校內出現通報個案、疑似個案或確診個案並 降低校園染疫風險,並協助學校執行傳染病防治法及學校衛生法之相關規定。
- 二、 校內住宿生如果快篩陽性或確診、或為確診者之密切接觸者,應**立即通報學校**,並依 標準作業流程做後續處置。
- 三、 本規定所稱密切接觸者,為確診者的同住家人或室友。
- 四、若知確診或為密切接觸者、卻未依規定通報、此舉已違反本防疫規定、視同違反陽明 校區之宿舍管理辦法第十八條、情節重大者得取消其住宿資格;此舉亦違反本校學生 獎懲實施辦法第八條第九款、第九條第九款等規定、將報請學校予以懲戒。該行為亦 可能因違反傳染病防治法相關規定而受裁罰。
- 五、 依照教育部指引,本校防疫宿舍規劃為提供輕症確診學生居住之「照護宿舍」。
- 六、 住宿學生若為確診者,除境外生、離島生及經濟弱勢學生(經生活輔導一組登記在案者)
 外,請返家(確診者禁止搭大眾交通工具、可以自行騎車、由家人接送或搭防疫計程
 車)。無法返家者,學校可協調申請入住檢疫所。
 - (一)若確診者為境外生、離島生或經濟弱勢學生,因無法返家,入住西安宿舍之照護 寢室。
 - (二) 同一確診起始日的學生,可安排同住一間,多人一室。
- 七、 住宿學生若為 0+7 方案之密切接觸者,於 7 天自主防疫期間,得留宿原寢室。每位密 切接觸者領用 4 劑快篩劑,每兩天快篩一次,快篩結果拍照保存。若快篩呈陽性,需 立即通報學校。
- 八、 確診住宿生於隔離期間,原寢宿舍大門得予以門禁管制,隔離期滿後解除門禁管制。
- 九、「確診者」於居家照護(前5日)+自主健康管理(後n日)期間:

(一) 居家照護隔離期間:

- 確診日次日起算需進行隔離 5 天,隔離期間留在房間,禁止外出。請參考衛 福部疾病管制署「COVID-19 確診個案注意事項」 <u>https://www.cdc.gov.tw/File/Get/RODf7BeMb_RfgSFjuTW3pQ</u>以及 「COVID-19 確診個案居家照護應注意事項」 <u>https://www.cdc.gov.tw/File/Get/B4uVVje d62uiyZ11V0gyg</u>
- 於學校照護宿舍居家照護隔離期間,需留在照護寢室內,禁止外出。三餐將 由住輔員協助送到寢室門口。
- (二) 自主健康管理 n 天:
 - 居家照護確診者隔離滿 5 天後,若快篩陰性,無需進行自主健康管理;若快 篩陽性,應持續進行自主健康管理至快篩陰性日,或至距離解除隔離日滿 7 天。
 - 自主健康管理期,若無症狀,就可外出及正常生活,可以入校、入班上課, 亦可返回原寢居住。但仍應避免出入人潮擁擠、接觸不特定對象的公共場 域,禁止聚餐、聚會、公眾集會等群聚型活動。
- 十、「密切接觸者」自主防疫期間為0+7: 得於宿舍原寢室內進行自主防疫,無症狀且 有2日內家用抗原快篩陰性者,可到校(班)上班上課、有症狀者不得到校(班)上班上 課。

十一、 住宿生返回原寢後之清潔消毒, 由舍民自行清消

- 本校宿舍公共區域如浴廁、走廊、樓梯間等,校方清潔人員於週間每日進行清 消2次。
- 確診者或密接者:返回原寢時,請先開窗通風,再以酒精或稀釋漂白水自行清 消。若寢室需清消用品,得向各舍住宿輔導員室借用,並於用畢後歸還。

Student Dormitory Epidemic Prevention Regulations

Announced Date: 2022/5/18 Amended Date: 2022/10/13 Amended Date: 2022/11/14

- I. These regulations are enacted pursuant to the provisions of the Ministry of Education's "Guideline for the Management of Epidemic Prevention in Student Dormitories for Severe Special Infectious Pneumonia in Colleges and Universities" and the Ministry of Education's New Epidemic Prevention Guideline for Colleges and Universities (2022/11/07). The purpose of these regulations is to reduce the risk of spreading of COVID-19 on campus, and to assist school in implementing the Communicable Disease Control Act and the School Health Act.
- If you are students who live in Yang Ming campus dormitory and test positive from a rapid test of COVID-19, or you may be a close contact of a COVID-19 confirmed case (a roommate, a family member who lives with you), please notify the University epidemic prevention authority staff immediately and follow the instructions given by the school authorities. Office hours on weekdays: call 02-2826-7000 ext. 67212, 62952 (Student Health Center); Outside office hours or on weekends/holidays: call 02-2826-1100 (School Safety Center).
- III. If you are a COVID-19 confirmed case or a close contact but fail to report to the school, you are subject to disciplinary action for violation of dorm regulations and the Regulations on Student Commendation and Disciplinary Sanction Measures of NYCU. Staying in current dormitory is prohibited, which may also be fined by the government due to against the "Communicable Disease Control Act".
- IV. In accordance with the guidelines of the Ministry of Education, the university's epidemic prevention dormitory shall include the "care dormitory (room)" for COVID-19 confirmed students with mild symptoms.
- V. If you are a COVID-19 confirmed case, please return home for your quarantine. Only international students, students who live in offshore island, and students who are economically disadvantaged will be relocated to the university's epidemic prevention dormitory.
- VI. If you are a COVID-19 confirmed case and qualify for moving in the university's epidemic prevention dormitory for isolation, you will be relocated to the "care room" inside the Shi-An dormitory. Your dormitory access will be temporarily cancelled for 5 days. Entering the campus dormitory is strictly prohibited in this period.
- VII. Confirmed COVID-19 cases: 5-day isolation + n-day self-health management:
 - A. 5-day isolation period (Day 1 to 5)
 - 1. The day of being diagnosed as having COVID-19 infection will be day 0. You need

to stay in the care room and are not allowed to go out for 5 days.

- 2. You need to order and prepay your own meals and have the delivery sent to the Shi An Dormitory (outside the front door of the building). Then your food will be brought to you and left outside your room door by the dorm manager.
- 3. You can move back to your campus dormitory on day 6 and start your n-day self-health management period.
- B. Self-health management period (Day 6 to Day n)
 - On day 6, you will be released from the isolation. If the result of the rapid test is negative, there is no need for self-health management. If test is positive, you need to start a self-health management period until day 8 or the day that your rapid test is negative, whenever comes first.
 - During the self-health management period, if you do not exhibit any symptoms, you may go about your life normally. You can move back to your campus dormitory, enter the campus, and attend classes.

VIII. Self-initiated epidemic prevention period for "close contact": 0+7

- Individuals who are close contacts should undergo a 7-day self-initiated epidemic prevention. Each close contact will receive 4 rapid test kits. Please perform the rapid test once every two days, and take photos of all rapid test results. Save the photos for future inspection. If the test is positive, you need to notify the University epidemic prevention authority staff immediately.
- During the 7-day self-initiated epidemic prevention period, you can move back to your campus dormitory. However, proof of a negative result from a rapid test taken within 2 days should be presented if you need to enter school campus and attend classes.

IX. Sanitation and Hygiene Advisory for Dormitories

- A. When return to your own campus dormitory, please first open the windows and sanitize your room with alcohol or sanitizer.
- B. You may borrow cleaning products and disinfectants from the dorm manager's office and return them back after use.
- C. Public areas such as bathrooms, corridors, stairs, etc., are routinely cleaned and disinfected by janitors twice a day Monday through Friday.
